Purpose

Collect diverse perspectives from community members, Tribal governments, and key stakeholders to shape the PCIP Community Engagement Plan

- **Build Awareness:** Educate stakeholders on the PCIP project and its potential impacts through proactive outreach.
- **Gather Input:** Identify concerns, desired outcomes, and mitigation ideas to align the project with community priorities.
- **Foster Trust:** Engage stakeholders early to demonstrate transparency and build lasting relationships.
- Address Barriers: Identify challenges to participation and develop strategies to ensure inclusive engagement.
- Enable Collaboration: Use stakeholder insights to design an equitable and meaningful engagement plan.

Process

Utilize interviews and an online questionnaire with an iterative approach to gather broad perspectives and ensure inclusive outreach

- Comprehensive Consultation: Stakeholder interviews and an online questionnaire were used to collect diverse perspectives.
- Iterative Approach: A "snowball" method expanded engagement by leveraging connections and recommendations from participants.
- **Inclusive Outreach:** The online questionnaire provided an opportunity for individuals unable to participate in interviews to share their input.
- **Informing Engagement:** Insights gathered directly shaped the Community Engagement Plan to align with stakeholder priorities for the NEPA process.



- Ongoing presentations to Tribal Councils, community organizations, neighborhood associations, government agency boards and commissions and business groups.
- Ongoing updates to Port Commission.
- Project Advisory Group meetings will be held in a hybrid format for in-person and virtual participation.
- Open house/town hall meetings will have an online component to allow virtual participation.
